

Applicants with foreign secondary education (General Admission)

International Student

Applications are made directly to Atlântica.

Students who fulfill all of the following requirements may apply:

- Students who have completed High School/K12 or who have legally equivalent qualifications;
- Students who have taken the required entrance examinations - Applicants who completed their secondary education abroad will need to validate their school-leaving exams, in accordance with the Portuguese national exams required for admission to each study programme at Atlântica. The required exams may be carried out at the school itself (even by videoconference or other technological means to perform interviews);
- Student's grade in each of the required entrance examinations must be above the established minimum - The grades obtained in the school leaving exams required must be at least 95 on the Portuguese scale from 0 to 200; Atlântica will undertake the necessary equivalence procedure from the original educational system;
- Students who meet the prerequisites required for admission;
- Student's application grade must meet at least the established minimum - Minimum application grade: 95 (grading scale: from 0 to 200).

The final High School/K12 grade is worth 65% in the formula for calculating the application grade. The required entrance examinations are worth 35%.

The national exams are valid for the year they are taken and the subsequent two academic years.



Prerequisites

Candidates for degrees in health sciences at the Atlântica are must comply with a set of prerequisites which may eliminate their application (apt or inapt)

- Medical certificate stating that they are "Apt" – Medical certificate form given by Atlântica

Language requirements

Lectures are given mainly in Portuguese (it depends on the degrees) and if you plan to attend regular courses you should have some knowledge of both written and spoken Portuguese. Atlântica has lectures given in English in some degrees.



Application Documents

- a) Application form given by Atlântica (on-line or in paper);
- b) A copy of passport/identification document (applicants from outside the European Union must prove their legal status to reside in Portugal, according to the Border Service rules (SEF - Serviço de Estrangeiros e Fronteiras);
- c) Proof of recognition of secondary education level, issued by the relevant Portuguese authorities (Embassy);
- d) A statement from the Director-General of Higher Education, allowing the substitution of national exams by exams performed abroad – if applicable;
- e) Vaccination Certificate (hepatitis B vaccine and tetanus) – only for degrees in healthcare

Note: to obtain the documents mentioned in d) and e), applicants must present a certificate showing that they completed secondary education in another country, together with the final grade and the grades of the required final exams. These documents must be authenticated by the official education services of their home country and recognised by the respective Portuguese diplomatic authorities (or bear The Hague Convention stamp).

▀ Students who require an entry visa or don't have documents

Students who require a visa to study in Portugal will receive a Letter of Acceptance after their application has been processed and after they have paid all the necessary fee. It is the students' responsibility to ensure that they follow all procedures required for a visa and for their legal entry into Portugal. Students can not arrive without a valid visa. And they will not be registered for their proposed courses if the documents are not valid and if they did not pay all the fee - this will be reported to the Portuguese authorities. All students must arrive with all the legal and original documents and with having paid the fees - this is the conditions to be registered for their proposed courses.
